### NOTIFICATION

In pursuance of the communication received from the Department of Higher Education, Government of Himachal Pradesh, vide letter No. EDU-A-A(01)13/2024-282719-SPU dated 27-08-2025, and after due consideration of the recommendations therein, the following instructions are hereby issued for strict compliance by all Principals/Heads of the affiliated colleges of Sardar Patel University, Mandi (including the colleges of Kangra & Chamba):

1. Students of the 2022-23 batch admitted under SPU-Mandi (including those from the districts of Kangra and Chamba, now under HPU) shall continue under SPU until the completion of their UG programmes.
2. Government Degree College, Rakkar and all other colleges located in Kangra and Chamba districts are permitted to provisionally admit eligible students of the 2022-23 batch to the 3rd year, based on the revised promotion rules of Sardar Patel University, Mandi, subject to verification of academic records.
3. Students of Biotechnology and other courses admitted under SPU in 2022-23 in colleges located in Kangra/Chamba districts shall be allowed to complete their degrees under SPU, even if these courses are not presently available in the affiliated institutions of SPU.
4. Sardar Patel University is further permitted by the Govt. of H.P. to conduct annual/semester/compartement/reappear/golden chance examinations for these students. At the same time, such students shall continue their further studies in their original colleges where they were initially admitted in the first year, irrespective of the fact that such colleges have now come under the jurisdiction of Himachal Pradesh University, Shimla.
5. Further, it is hereby notified that the last date for admission to Undergraduate classes (UG) for the session 2025-26 has been extended up to 05-09-2025.


