

Boxing Coach Required under Khelo India Scheme

Applications are invited for the appointment of a Boxing Coach in the MLSM College under Khelo India Scheme of SAI (Ministry of Youth Affairs & Sports), purely on contract basis. The duly completed application form (available on www.mlsm.in) should be submitted in the office of the Principal on or before 20.02.2021 up to 5:00 pm. by hand/Regd. Post / Speed Post.

A Eligibility & other service conditions for the appointment of Past Champion as Coach.

1st preference – Represented India at recognized international competition under recognized NSF/Association of respective sport.

2nd preference – Medal winner at Senior National past championship conducted by recognized NSF or Medal winner at Khelo India Games

3rd preference – Medal winner at National AIU past championship.

4th preference- Represented State in Senior National past championship conducted by recognized NSF or Participation in Khelo India Games.

B Age Limit: Maximum age limit for applicants will be 40 years, However, relaxation may be accorded in deserving case.

C Tenure: The contractual engagement will be initially for a period of 01 year which could be further extended on the basis of performance.

D Remuneration: Fixed monthly remuneration of Rs. 25000/- i.e. Rs. 3.00 lakh per annum.

E Eligibility Documents

The eligible and interested candidates may report with their original educational, professional, sports' achievement certificates, ID proof and Aadhar Card in the office of the Principal, MLSM College, Sundernagar (HP)

F Tax Deduction at Source: The income tax or any other tax liable to be deducted as per the prevailing rules will be deducted at source before effecting the payment.

G Other Allowances : No TA/ DA shall be admissible for interview and joining the assignment or on its completion. No other facilities like DA, accommodation, residential phone conveyance / transport, personal staff, medical reimbursement, HRA and LTC etc would be admissible.

H Extension : Performance of the selected candidates would be continuously reviewed and their extension will be considered on the basis of periodic review/ requirement.

I Leave: They will be entitled for 30 days leave in calendar year on pro-rata basis. Un-availed leave in a calendar year will lapse and will not be carry forwarded to the next calendar year.
